TRASH AND RECYCLE GUIDELINES

1. Place trash materials in trash bags. Dispose of trash bags in trash rooms located on each floor. Make sure that you push the bags completely through the chutes. **DO NOT LEAVE TRASH BAGS ON THE FLOOR. DO NOT PUT TRASH OR TRASH BAGS IN, ON, OR NEAR THE GARAGE RECYCLE BINS.** Trash bags may also be placed **in the dumpsters** located inside the garage trash rooms located behind the roll-up door. Don't forget to close the door completely (by HOLDING the middle Green button) when finished.
2. **Place recycle materials in the bins marked for recyclables.** Recyclable items include: aluminum & steel cans, glass bottles & jars, plastic bottles, paper & cardboard boxes. (See posters displayed in the recycle/trash area). You do NOT need to separate recyclable items – Baltimore County uses single stream recycling – and you only need to lightly rinse containers, not wash them fully.
3. **Put only recyclable materials into the recycle bins.**
 - a. **DO NOT put trash (garbage) in the recycle bins. Put trash (garbage) in the dumpsters in the trash room (and please close the trash room door when done)**
4. **Break down (flatten) all cardboard boxes.** If boxes do not fit in the recycle bins, **DO NOT PLACE BOXES ON TOP OF THE BINS.** Place flattened boxes in a vertical position between or alongside the bins. Boxes that contain other recyclable material or cannot be broken down should be stacked next to the bins, not on top of them.
5. **Bulk trash items may not be left in the recycle area.** Bulk trash is anything that cannot fit into a standard trash bag. We have two methods for **you** to get rid of bulk trash:

Baltimore County Trash Drop Off Facility – Central Acceptance Facility (CAF); 201 West Warren Road, Cockeysville 21030, off I-83 North at Warren Rd, Exit 18, Go 1 mile, CAF drop off is on the right.

Contact a member of the Building Operations and Security Committee.

For a \$15 fee (payable to the 2700/2800 Stone Cliff Condominium Association, Inc.) you will be able to arrange to bring your bulk item to a specific storage room in the garage. When there are enough items, they will be hauled to the County Acceptance Facility.

6. **PAINTS, POISONS, MEDICATIONS, HAZARDOUS WASTE, ELECTRONICS AND LIGHT BULBS CONTAINING MERCURY MAY NOT BE DISPOSED OF IN THE TRASH.** Call the Baltimore County Department of Solid Waste at (410) 887-2000 for information on how to dispose of these items. They generally can be disposed of at the White Marsh Drop Off Facility from April through November, but call or check the website to be sure.
